All Declarations of Candidacy Forms and Candidate’s Form 700s must be actually received by Steele Canyon High School **no later than 3:30pm August 31, 2022 (no exceptions)**. Page one – will be used to inform the certificated staff of who is running for the vacant Certificated Staff Board Member position. It will be available for public viewing and a copy will be included in the ballots. A resume may be sent in addition to, but **not** in lieu of, the Declaration of Candidacy Form. Resumes will be kept in the Election binder in the school office only for public viewing.

Page two – will be kept in a confidential file and used to certify your eligibility.

Certification:

Candidates must complete a Fair Political Practices Commission Candidate’s Form 700, Statement of Economic Interests, at the time of declaration, which is available on the fair Political Practices Commission website (www.fppc.ca.gov). Elected Board Members must also complete a Form 700 when assuming office, on an annual basis and upon leaving office.

I certify each of the following:

1. All of the information I have stated above is true.
2. I have submitted a Candidate’s Form 700, in accordance with applicable law.
3. I have read the Steele Canyon High School Charter and Bylaws.
4. I am eligible to become a candidate, in accordance with the Steele Canyon High School Charter, Bylaws, and adopted Staff Board Election Policy, and that I am: a) a certificated employee of SCHS with a minimum of two (2) years of prior service at the school; b) not an administrator, manager, or supervisory personnel whose responsibilities include discipline, hiring or promoting other SCHS employees; c) have not been convicted of a felony; d) have the ability to attend at least 80% of regularly scheduled Board meetings and workshops and; e) have a willingness to actively support and promote the purposes and operations of the school, and a dedication to its educational philosophy and goals.
